This matter concerns serious lapses in cleanliness and maintenance within the premises of the Chottanikkara Temple. In our order dated 20.08.2025, we had observed that the photographs produced along with the petition depict widespread filth and decay, including in the kitchen and adjoining areas. The materials reveal a complete lack of hygiene and sanitation. The complaint further discloses misconduct on the part of the temple staff, a marked deterioration in the quality of offerings made to the deity, and a conspicuous failure of effective oversight by the vigilance wing.

- 2. We note that the District Co-ordinator, Navakeralam Karma Padhathi, has issued a communication dated 11.03.2025 to the 4th respondent, recording that several defects had been detected during inspection. He recommended, inter alia, the provision of a proper bin system to segregate plastic, paper, bottles, and organic waste, the installation of a water-treatment plant for safe dispensation, and the setting up of an incinerator in accordance with the specifications of the Pollution Control Board, along with various other remedial measures. Several of the directions have not been complied with.
 - 3. Having considered the facts and circumstances, we are of the view that

the presence of the Executive Director of the Suchitwa Mission, the Executive Engineer of the Maramath Wing of the Cochin Devaswom Board, and the Assistant Engineer of the Chottanikkara Devaswom is necessary for the effective adjudication of this matter, so that appropriate and enforceable directions can be issued.
