ORAL ORDER

(PER: HON'BLE MR. VIBHU BAKHRU, CHIEF JUSTICE)

1. The petitioners have filed the present petition as a Public Interest Litigation [**PIL**], *inter alia*, impugning the notification dated 19.11.2025 bearing No.UDO-293-BBS/2025, passed by respondent No.3, with regard to Ward No.43-'Beereshwaranagara' Ward. The petitioners seek that the said ward be renamed as 'Chunchaghatta'.

2. First of all, we find that no fundamental rights of the petitioners or any other person are violated by naming the ward as Beereshwaranagara. Whereas, the petitioners may be of the



opinion that the ward in question should be named as Chunchaghatta Ward, clearly, this is not a cause which should engage the judicial time of this Court.

3. Any opinion that the petitioners may have or any thought that may pass through their mind cannot be transcribed into a public interest litigation. This is an unjustifiable imposition on judicial time.

4. In view of the above, the present petition is dismissed with costs quantified at Rs.5,000/-. The costs shall be paid to the Karnataka State Legal Services Authority within a period of two (02) weeks from date.
